Course Summary

The purpose of the course is to prepare nurses who can assess, plan, lead and co-ordinate the delivery of high quality, person-centred, holistic care, which is underpinned by an evidence base.

Course Aims

The aim of the course is to equip students with the skills and knowledge to:

- Care for people across the lifespan, within all healthcare environments
- Deliver evidence-based, safe, and compassionate care
- Become adaptable, competent practitioners, capable of working in a multi-disciplinary team

Awards

On successful completion of the course, students will be awarded a MSc Adult Nursing (Preregistration) and will be eligible to register with the NMC as an Adult Nurse. Students who successfully complete 180 credits but do not pass the Adult Nursing practice element may be eligible for a MSc Health Studies but will not be eligible for registration with the NMC. Students who leave the course early may be eligible for a PgD Health Studies on successful completion of 120 credits or a PgC Health Studies on successful completion of 60 credits, although these exit awards will not enable students to apply for entry to the Nursing and Midwifery Council register.

The course is delivered at the University of Suffolk Ipswich campus. Students studying full-time on MSc Adult Nursing (Pre-registration) are likely to have approximately 640 contact hours. The contact hours will be a mix of lectures, seminars, tutorials, workshops and skills-based practical workshops. Students will also be required to engage with guided study activities through the on-line learning platform Brightspace and other mandatory e-learning across other platforms. Due to the accelerated nature of the course students will be expected to complete 43 hours of study per week (inclusive of: direct contact hours, preparing for contact sessions, online activity, assessment preparation and independent study), to meet the required 2300 theory hours. Students will also be required to demonstrate the completion of 2300 clinical hours in practice placements across a range of clinical placement settings. Placements will be arranged by the University.

Course Assessment

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall will include summative and formative assessments of coursework (including essays, reports, presentations, group work, reflective learning journals and research projects) examinations and practical assessments.

Special Features

On successful completion of the MSc Adult Nursing (Pre-registration) students are eligible to apply for registration with the Nursing and Midwifery Council. This does not apply to students exiting the course with PgC/PgD/MSc Health Studies award, who will not be eligible for registration.

Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute and are registered with the appropriate professional body, including the NMC or HCPC.

Course Costs

Students undertaking MSc Adult Nursing (Pre-registration) will be charged tuition fees as detailed below.
